## RECOGNITION

---

You are required to acknowledge the SC Bar Foundation's support by including our name and logo in publications, programs, and signage for any event or presentation that received grant funding.

- Always use our full name **“South Carolina Bar Foundation”** or **“SC Bar Foundation”** when referencing us.
- Where possible, please include the written acknowledgment below along with the logo:  
**“This grant was made possible by the South Carolina Bar Foundation.” – OR – “This project was funded (or funded in part) by a grant from the South Carolina Bar Foundation.”**

## LOGO USE

---

Below you will find several logo variations. Use the one that best fits your publication. Always place the logo upright and do not alter it in any way.

Acceptable uses of the SC Bar Foundation logo include, but are not limited to:

- Newspaper ads, TV ads
- Newsletters, postcards, brochures
- Websites and social media channels

We encourage you to use the SC Bar Foundation logo whenever it is suitable.

Feature the grant award in newsletters, e-blasts, social media, donor update letters, and on your website. Include a compelling photo of the project, the people you are serving, or another relevant visual element.
